



NOMINATION PROCESS FOR CITIZEN OF THE YEAR

SELECTION CRITERIA

All citizens of the Prince George Region are eligible except the directors of the Prince George Community Foundation and their immediate families.

Nominees shall:

- have exemplified above average volunteer or philanthropic dedication to the Prince George community;
- have provided volunteer service for a minimum of three years (not necessarily with the same volunteer organization);
- not have received any remuneration for the volunteer activity for which the award is being proposed or;
- have voluntarily performed duties related to their paid employment significantly beyond what is expected of a person holding that paid position. In this case, please explain how the nominee's commitment to the community exceeded the normal requirements of their paid employment;
- have signed a form agreeing to stand for nomination and have signed waivers stating that, if chosen as finalists, they are willing to have their names published and information related to the nomination made public;
- agreed to participate in events and publicity related to the Citizen of the Year.

Please note that the Prince George Community Foundation will archive the nomination packages of the finalists with a copy to each nominator and finalist.

Re-submissions of finalists will not normally be accepted in consecutive years. Nominations may be submitted sooner if there are additions to the nominations portfolio.

PREPARE WRITTEN SUBMISSIONS BY JUNE 1

Include:

- Letter of nomination.
- Documentation of Volunteer Service: length of time serving the community, value of service to the community, variety of contribution, breadth and quality of impact of service given.
- Documentation of Philanthropy (where this factors in nomination): value of philanthropy to the community, groups/individuals affected, length of time involved.
- Documentation of Visibility in the Community: how widely known in the community is the nominee for his/her volunteerism or philanthropy?
- Support for Nomination: type of support given, groups/individuals supporting nomination, third party support, documentation (clippings, photographs, etc.)
- Waiver from nominee re: Agreement to stand as nominee.
- Waiver from nominee re: Publication of name and information related to nomination.
